## ANIMAL WELFARE ADVISORY COMMITTEE - TEMPORARY HOUSING CODE

Over a period of twelve months, The Animal Welfare Advisory Committee has brought together a group of interested pet people to write a Temporary Housing Code for Pet and Companion animals in New Zealand. Under the leadership of Bob Kerridge from the SPCA Auckland, the Code has been gradually formulated trimmed and retrimmed to give a quick and easy reference for those associated with Pet Keeping.

Those who are assisting with the Code come from a wide group in the industry. They include SPCA, Boarding Kennels, Groomers, Catteries, Unitec Animal Behaviourists and Welfare Lecturers, Pet Shops, Cat Rescue Groups, Mahurangi Technical Institute, Pet Industry Association etc. This is a very enthusiastic group and it is great that Mike Tasker (Chairman of the PIA) and Jill Fraser (PIA Member) have been able to represent the Pet Industry on this committee.

It is great that such a diverse group are working together to produce this workable draught. We hope that in the future PIA will be involved in similar legislation and provide useful, useable input.

The writing group has been very thorough in covering all issues and scenarios that may eventuate in The Temporary Housing Code. Areas covered are:

- Characteristics of temporary housing establishments
- Definitions of establishments
- Responsibilities of manager, owner or person in charge.
- Housing
- Hygiene
- Health
- Release

There has been much discussion under each of the above headings and many ideas have been used to make this draught workable. Further meetings are proposed and it is hoped the Code will be finished by the end of this year.
